<sup>4</sup>GIFT AID If you are a UK taxpayer, and you tick YES to the Gift Aid declaration, then Sea of Faith can reclaim from HM Revenue & Customs 28p for each pound of your payment, but excluding the cost of the magazine, i.e. for each individual member, paying a subscription of £30, £15 can be treated as Gift Aided.

Any additional donation can also be Gift Aided and if the total payment, subscription plus donation, is £60 or more, then the whole amount, including the cost of the magazine, can be treated as Gift Aided and the member becomes a Sponsor. But please note:

You must pay an amount of income tax and/or capital gains tax at least equal to the tax that the Trust reclaims on your donations in the tax year (currently 28p for each £1 you give).

You can cancel this declaration at any time; notifying the Trust by writing to the Network Secretary.

If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax the Trust reclaims, you should cancel your declaration.

If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
